Magyar Telekom purchased treasury shares

Budapest – June 1, 2018 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: MTELEKOM HB, hereinafter the "Company"), the leading Hungarian telecommunications service provider, hereby announces that on May 31, 2018, to enable the operation of the incentive program based on the remuneration policy announced on March 28, 2018, the Company purchased 193,800 Magyar Telekom ordinary shares (HU0000073507) at an average price of HUF 416 per share. The share purchase was carried out on the Budapest Stock Exchange through UniCredit Bank Hungary Zrt., as investment service provider. Following this transaction Magyar Telekom holds 2,665,946 treasury shares.
