General Meeting approves MakTel dividend

Budapest – April 4, 2012 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: BÉT: MTELEKOM HB), the leading Hungarian telecommunications service provider, announces that its subsidiary, Makedonski Telekom AD – Skopje (MakTel), has reached a decision at its General Meeting on a total dividend payment of MKD 6.16 billion (around HUF 29.5 billion at the April 3, 2012 HUF/MKD exchange rate of 4.78) for the financial year 2011.

According to Macedonian Accounting Standards (MAS), on a standalone basis, MakTel recorded a net income of MKD 6.16 billion for 2011, all of which will be distributed in line with the decision of the General Meeting.

Stonebridge Communications AD Skopje (under liquidation), which is 100% owned by Magyar Telekom, is entitled to a dividend of approximately MKD 3.49 billion (HUF 16.7 billion).
