The Subscriber accepts that

Termination of the contract will not release the Subscriber from the obligation to pay his debts under this contract and the fees charged during the term of the contract. If the definite term of the Individual Subscription Contract or the period defined in the definite term Master Subscription Agreement has not expired yet, Magyar Telekom Plc. may charge the penalty applicable according to the provisions of above contracts to termination before the expiry of the definite term of the contract for the given tariff package, device or service.

This document is used to provide proof of termination by the subscriber/to terminate the Individual Subscription Contract and/or Master Subscription Agreement. The Subscriber gives his consent that the Service Provider may within 30 days of communication of the termination, or if the Subscriber specifies a different date for the termination, than by that date contact the Subscriber on the dedicated telephone number specified above for coordinating the details of cancellation of the Individual Subscription Contract/Master Subscription Agreement. The Subscriber accepts that if the Service Provider cannot contact the Subscriber within the above specified period after communication of termination of the contract at the contact points and times specified by the Subscriber for coordinating the details of cancellation, the Subscription Contract/Master Subscription Agreement will expire according to the statement made by the Subscriber at the latest on the 30th day following communication of the termination statement to the Service Provider or at a later date specified by the Subscriber. The date specified by the Subscriber as date of expiry of the contract may be between the eighth and thirtieth day after the sending of the termination notice. In this case the Subscription Contract/Master Subscription Agreement will expire on this date.

The Subscriber agrees to pay the costs incurred in connection with the use until the date of expiry of the above contract after the receipt of the relevant bill by the payment deadline specified therein.

If the Service Provider provided to the Subscriber terminal equipment/device owned by Magyar Telekom Plc. (hereinafter referred to as: device) for the use of the service, the Subscriber shall immediately after the cancellation of the above service(s) return them to the Service Provider, otherwise he shall compensate the Service Provider for all its damages, or if the device not returned suffers any damage, the Subscriber will be liable for all such damage according to the General Terms of Contract and the relevant regulations of the Civil Code.
